Because of the Covid-19 Pandemic, teachers are working full remote from September, 1, 2020 until November 16, 2020 (subject to change.) Teachers have provided parents with their scheduled office hours during which time they may work with students/parents on individual issues or small group instruction, as well as schedule conferences with parents (8 am – 8:55 am and 2:05 pm – 2:55 pm Monday through Thursday).
 5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows;

Parents are not allowed to come to the building for any activities during the Covid-19 pandemic crisis per district protocol.

Parent Responsibilities
