Any matter involving the purpose, lease or acquisition of real property with public funds, the setting of bank rates investment of public funds where it could adversely affect the public interest if discussion of such matters we disclosed;

Any tactics and techniques utilized in protecting the safety and property of the public provided that their disclosure cou impair such protection;

Any investigations of violations or possible violations of the law; Any pending or anticipated litigation or contranegotiation in which the public body is or may become a party. Any matters falling within the attorney-client privilege to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer.
